Terms And Agreement

_____ I agree to rent the above instruments for \$60 per month, due in advance on the first day of each month. John Kaboff and I agree that this is a month to month contract and can be terminated at any time and for any reason by either party. The cello and bow would need to be returned immediately to and inspected by John Kaboff. I fully understand that I must obtain, in writing, a signed release from John Kaboff for the return of the above instruments to consider this contract terminated.

Damage

_____ I fully understand and agree that ANY damage to the cello and/or bow will be reported immediately to JOHN KABOFF and be inspected by MICHAEL WELLER of WELLER VIOLIN'S for an assessment of condition. In addition, I FULLY agree that I am SOLELY financially responsible for all repairs of ANY damage to the cello such as new cracks, the opening of old cracks and seems, scratches and nicks up to the amount of \$500.00. I also understand that an initial repair estimate may vary from the final total cost to repair the cello/bow. ANY repairs needed to the cello or bow will only be performed by MICHAEL WELLER of WELLER VIOLIN'S and DONALD COHEN, Bow maker. Both are located at 110 S. Columbus St., Alexandria, VA.

Insurance

_____ I have been advised and agree to list the cello and bow on my homeowner's/renter's insurance policy. I understand that the instruments are insured for John Kaboff by the Heritage Insurance Services/St. Paul Fire & Marine Insurance Company. I understand that his policy will cover him for any damage and/or loss to the instruments and reserves the right to subrogate and collect its losses from me personally. I have been made aware that his insurance deductible is \$500.00 and agree to reimburse John Kaboff immediately should he need to make an insurance claim for any reason.

Care And Maintenance And Responsibilities

I, _____ (the parent) will monitor the following maintenance steps with my child and encourage the proper handling and care of the instruments rented from John Kaboff.

1. My child will wash his/her hands before beginning to play the instrument every day
2. My child will loosen the bow each time I set it down and cease playing the cello
3. My child will store his/her cello in its case each time he/she leaves the practice room
4. I will never leave the cello in a locked car or in direct sunlight
5. I will maintain proper humidity in the house as prescribed by John Kaboff
6. John Kaboff and I have discussed climate and humidity control for the cello _____
7. My child will not attempt to tune the cello without me present.
8. Broken strings are the renter's responsibility and will be replaced with the following strings; Larsen Soloist A/D Heliocore G/C for 1/4 , 1/2 , 3/4 and 4/4 size cellos.
10. John Kaboff will restring each cello one time per school year. (September 1)

Rental Credit Policy

Effective September 1, 2005 or the commencement of this agreement (whichever is later), John Kaboff agrees to apply \$25.00 monthly accrued "rental credit" (\$300 per calendar year maximum) towards the purchase of a FULL (4/4) size cello and/or cello bow only from John Kaboff. Rental credit applied towards a purchase may NOT exceed 50% of the sales price of the cello and/or bow. Rental credit is void if lessons between John Kaboff and the student are terminated for any reason by either party.

Full size cellos range in price from \$2,500 - \$12,000.
Full size bows range from \$400 - \$7,000.
